The Organization holds valid FSC certificate with transfer system implemented.

The specific objective of this evaluation was to confirm that the Biomass Trader's management system is capable of ensuring that all requirements of specified SBP Standards are implemented across the entire scope of certification.

The scope of the evaluation covered:

- Review of the Biomass Trader's management procedures;
- Review of FSC system control points, analysis of the existing FSC CoC system;
- Interviews with responsible staff;
- Review of the records and calculations;
- Review of the transportation, storage and deliverance processes

## 5 Description of Company, Supply Base and Forest Management

### 5.1 Description of Company

Organization is a trader without physical possession of wood with its legal address in Hong Kong. Its representative office in Russia is located in Irkutsk sourcing the biomass from two pellet producer in Russia, Irkutsk oblast. The material is delivered by suppliers by train to S.Petersburg sea port and sold to organization, which then sells it to its customers. Delivery conditions are FCA, S.Petersburg sea port (Incoterms 2010).

### 5.3 Detailed description of Supply Base

### 5.4 Chain of Custody system

The Organization has implemented the FSC transfer system with biomass (wood pellets) in the scope of the certificate - FC-COC-001112 <https://info.fsc.org/details.php?id=a02f300000gXEDDAA4&type=certificate> . The process covers trade with biomass (FSC 100%, FSC Mix Credit and FSC Controlled Wood claims), without physical possession. Non-certified biomass (other biomass) is not accepted.
